IF THE TOTAL BALANCE DUE IS NOT RECEIVED BY THE ARRANGED DATE, ALL-STAR EVENTS RESERVES THE RIGHT TO CONSIDER THE EVENT CANCELLED AND IS RELEASED FROM THE TERMS OF THIS AGREEMENT. PAYMENTS ARE NON-REFUNDABLE IF EVENT IS CANCELLED WITHIN TWO WEEKS OF CONTRACTED DATE.

### ENTERTAINMENT CONDITIONS

1. LOCATION MUST BE AVAILABLE AT LEAST 1 HOUR PRIOR TO START TIME FOR SET-UP.
2. IF THE EVENT IS OUTDOORS SHADE / SHELTER MUST BE PROVIDED IN ORDER TO COVER FOR THE DJ AND AUDIO EQUIPMENT. IN THE CASE OF INCLIMENT WEATHER, THE DJ WILL NEED TO TAKE DOWN HIS GEAR AND MOVE TO A SHELTERED AREA. A STURDY SURFACE TO PLACE EQUIPMENT ON MUST ALSO BE PROVIDED BY THE CLIENT.
3. PERFORMANCE HOURS CAN NOT BE EXTENDED WITHOUT A CHANGE IN RATE AFTER THE BOOKING AGREEMENT HAS BEEN SIGNED.
4. DEPOSITS ARE NON-REFUNDABLE HOWEVER, DEPENDING ON OUR AVAILABILITY, IT IS TRANSFERABLE TOWARDS A FUTURE DATE.
5. NEITHER PARTY SHALL BE LIABLE TO THE OTHER PARTY FOR ANY DELAY OR INABILITY TO PERFORM ITS OBLIGATIONS UNDER THIS AGREEMENT IF SUCH DELAY OR INABILITY ARISES FROM ANY ACT OF GOD, FIRE, NATURAL DISASTER, LOCKOUT, ACT OF GOVERNMENT OR ANY OTHER CAUSE BEYOND THE

CONTROL OF SUCH PARTY.

6. THE CLIENT IS LIABLE FOR ANY DAMAGES CAUSED TO ALL-STAR EVENTS STAFF / REPRESENTITIVES OR TO EQUIPMENT BY EITHER THE CLIENT OR BY THEIR GUESTS.

7. PARTIES WILL DEFEND, INDEMIFY, AND HOLD HARMLESS EACH OTHER, THIER MEMBERS, EMPLOYEES, OWNERS, CONTRACTORS OR GUESTS AGAINST ALL LIABILITY, LOSS, ACCIDENTS, COST OR EXPENSES ASSOCIATED WITH ANY CLIAMS, SUITS, ACTIONS, OR DEMANDS OF ANY NATURE AND DESCRIPTION BY REASON OF DAMAGE OR INJURY TO ANY PERSON OR PROPERTY CAUSED BY THE OTHER PARTY OR A CLIENTS NEGLIGENCE OR BREACH OF THIS AGREEMENT OR PERFORMANCE OF SERVICES.

8. ALL-STAR EVENTS RESERVES THE RIGHT TO ADJUST THE ANTICIPATED DJ IN ORDER TO BEST ACCOMIDATE FOR THE LOCATION, SCHEDULING, AND THE TYPE OF EVENT BEING BOOKED AS WELL AS IN THE EVENT OF AN EMERGENCY OR UNEXPECTED COMPLICATIONS WITH THE ANTICIPATED DJ.

9. ALL-STAR EVENTS RESERVES THE RIGHT TO DISCONTINUE SERVICES IF THE SAFETY AND OVERALL WELL BEING OF OUR STAFF BECOMES JEOPARDIZED IN ANY WAY

10. THIS AGREEMENT IS ONLY VALID AFTER BOTH PARTIES HAVE SIGNED THE AGREEMENT.
